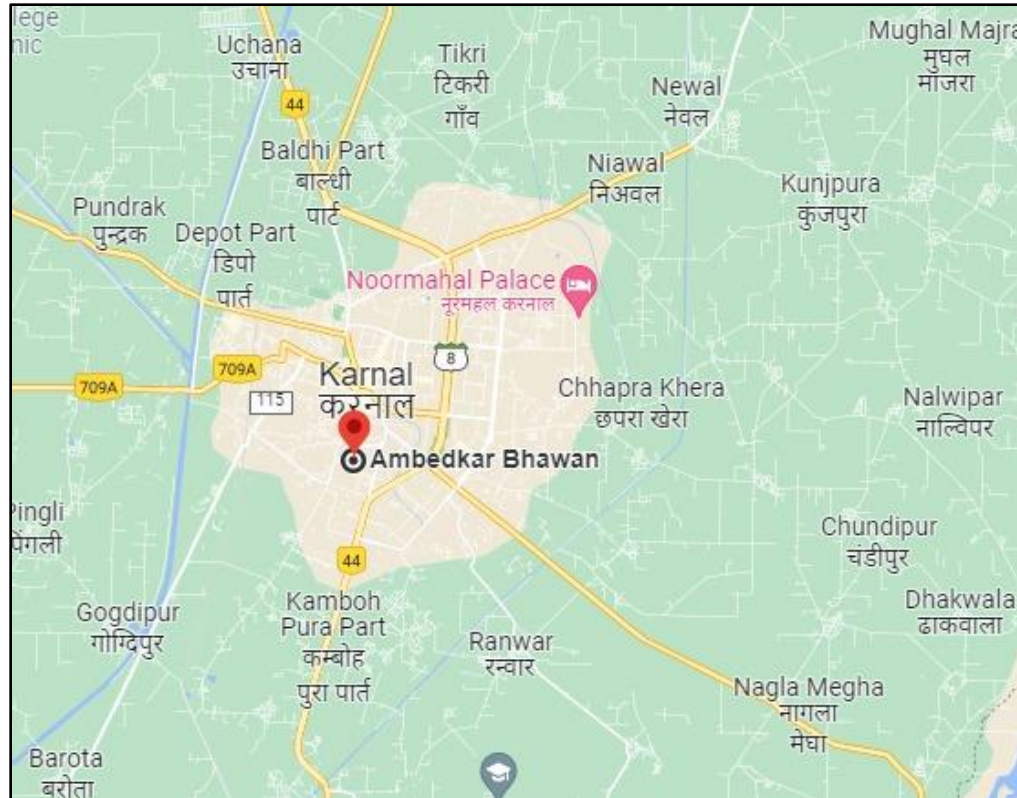


Introduction

13. Order for provisional approval:

14. After considering the application of the applicant and the material available on record, the applicant is hereby granted provisional approval with effect from the assessment year mentioned as serial no. 8 above subject to the conditions mentioned in rule number 10.

15. The feasibility, or otherwise, of the income of the applicant would be separately considered as per the provisions of the Income Tax Act, 1961.

16. This order is made to be withdrawn by the prescribed authority if it is subsequently found that the activities of the applicant are not genuine or if they are not carried out in accordance with all or any of the conditions subject to which it is granted, if it is found that the applicant has obtained the provisional approval by fraud or misrepresentation of facts or if it is found that the assessee has violated any condition mentioned in the Income Tax Act, 1961.

17. Conditions subject to which provisional approval is being granted:

The provisional approval is granted subject to the following conditions:

1. No change in the deed of the applicant trust/society/born profit company as any of its bye-laws shall be affected without the due procedure of law and the approval of the Competent Authority as the provisions of law and its variations shall be given immediately to Officer of the Jurisdictional Cases in case of Income Tax and to the Assessing Officer.

2. Any change in the trustees or officers of the applicant trust/society/born profit company shall be intimated to Officer of the Jurisdictional Commissioner of Income Tax and to the Assessing Officer.

3. The applicant trust/society/born profit company shall maintain its accounts regularly and also get them audited as per the provisions of section 80G(3)(iv) read with section 12A(1)(b)(ii)(C) of the Income Tax Act, 1961.

4. Certificate of donation shall be issued to the donee in form no. 10B/F, as per the provisions of rule 13AB.

5. No case or for any other consideration shall be received in violation of section 20(1) of the Income Tax Act, 1961.

6. The trust/society/born profit company shall file the return of assessment of its trust/society/born profit company as per the provisions of section 178(1)(4A)(a)(c) of the Income Tax Act, 1961.

7. The approval granted in this order shall apply to the donations received only if the applicant trust/society/born profit company, established in India for charitable purposes, fulfills the conditions laid down in section 80G(3)(iv) of the Income Tax Act, 1961 and the religious endowment shall be as specified in section 80G(5B) of the said Act.

8. If the applicant trust/society/born profit company derives any income, being profits and gains of business, it shall maintain separate books of account in respect of such business as provided in section 80G(3)(iv) of the Income Tax Act, 1961. Further, any donation received by the applicant shall not be used directly or indirectly, for the purposes of such business and a certificate shall be issued to every person making a donation to the effect that the applicant trust/society/born profit company is not engaged in the business and the donations received by it shall not be used, directly or indirectly, for the purpose of such business.

9. The applicant shall comply with the provisions of the Income Tax Act, 1961 read with the Income Tax Rules, 1962.

10. The approval and the unique registration number shall be mutually granted and if, at any point of time, it is noticed that the form for approval has not been duly filled in by the applicant, fully or partly, or by providing false or incorrect information or documents required to be provided under rule (1) or (2) of rule 11A or by not complying with the requirements of rule (3) or (4) of the said rule, the approval and Unique Registration Number (URN) shall be cancelled and the approval and URN shall be deemed to have never been issued or granted.

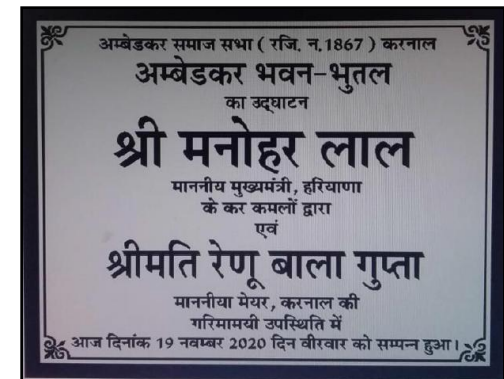
Celeberating Birth Anniversary of Baba Saheb Ambedkar Ji

- Women Entrepreneurs, members of self help groups , women leaders are recognized and felicitated







Skill Development and Livelihood Initiatives
